Welcome to www.BoroMela.com. Thanks for stopping by. By accessing BoroMela.com you are agreeing to the following terms, which are designed to make sure that BoroMela.com works for everyone. This policy is effective March 01, 2009.

Using BoroMela.com. You will post in the appropriate category or area and will not do any of the following bad things:

- violate any laws or our [Prohibited Content Policy](#);
- be false or misleading;

- distribute or contain spam, chain letters, or pyramid schemes;
